These improvements reflect our commitment to providing safe, innovative, and inclusive environments where every student can thrive. From new classrooms and collaborative learning areas to enhanced technology and sustainability features, these upgrades are already making a positive impact.

Even more exciting, our district has been honored with the Michigan Association of School Boards' **Education Excellence Award**—a prestigious recognition earned by only 10 districts statewide. This award celebrates our dedication to academic achievement, student support, and community engagement. It is a testament to the hard work of our elementary science educators, the curiosity and determination of our students, and the unwavering support of our families and staff.

We are also proud to share that the latest state assessment scores have been released, and Anchor Bay once again ranked near the top of the county. Overall, our district achieved the highest English Language Arts and Reading composite proficiency across all grades for the second consecutive year. In addition, Anchor Bay placed second in the county for composite proficiency in Math, Science, and Social Studies.

As we begin this new chapter, we carry forward the momentum of these accomplishments with pride and purpose. Let's continue to build on our success, support one another, and make this school year one of growth, joy, and excellence.

Here's a look at the progress made over the summer:


Lighthouse Elementary

This summer, Lighthouse Elementary received several upgrades that enhance safety and create a motivating learning environment. Improvements include updated fire alarm systems, ceiling and drywall installation, fresh paint and new flooring.

Lighthouse Elementary received a new playground and facility upgrades in preparation for its conversion into an Early Childhood Center by 2028.

Middle School South

At Middle School South, bond-funded renovations focused on enhancing specialized learning spaces. The band room received a thoughtful refresh to better serve our music program, and the small engine room was updated to support hands-on learning for students exploring technical education pathways. Outside improvements included new restrooms by the athletic fields.

Middle School North

Middle School North saw a major transformation this summer, especially in our 5th grade classrooms. Renovations included enlarging classrooms by revising wall layouts in a 4-to-3 and 3-to-2 conversion approach. This heavy construction included masonry and demolition, new drywall, fresh paint, updated ceilings and flooring, and the exciting addition of a brand-new playground. Elements of the playground were voted on by our students.

These changes create a brighter, more engaging environment for our students to learn and grow.



Anchor Bay High School underwent significant renovations across several key areas.

The media center and athletic wing were renovated, a new pump station was installed, and work began on innovative engineering pathways and a dedicated Student Success Center. Also, our new addition featuring the kitchen, serving area, auto shop as well as robotics, engineering and welding will be operational this fall. These updates are designed to expand opportunities and support student achievement now and into the future.

Away-for-the Day Device Policy

Anchor Bay Schools has implementing a "cell phone free" policy for all students during the school day. Under the new Away-for-the-Day requirements:

- Personal electronic devices must be turned off and stored out of sight during school hours. (Bell-to-Bell)
- The term "device" includes cell phones, personal laptops, smartwatches, earbuds, headphones, and other wireless communication devices.
- The policy applies to all students, with legal exceptions for those covered under the Americans with Disabilities Act (ADA), Individualized Education Programs (IEP), Section 504 Plans, or students with documented medical needs.

The district's goal with this policy is to minimize distractions in the classroom, encourage face-to-face interactions, and enhance overall student engagement in learning.

Extra-Curricular Eligibility Policy

Anchor Bay Middle and High Schools has implemented a new student eligibility policy.

To participate in extracurricular activities (including dances, athletics, clubs, and performances), students must:

- Have satisfactory citizenship in at least 5 of 6 classes.
- Pass all 6 classes.
- Maintain a minimum 2.0 GPA from the previous
- Athletes must adhere to the Anchor Bay Schools Athletic Code of Conduct.

Trimesters

Anchor Bay School District has moved to trimesters. Switching to a trimester schedule offers several positive opportunities that benefits students, teachers, and overall school operations.

Parent – Teacher Conference Week will run for a twoweek period at both the elementary and secondary level. The conference window will run from October 6th-17th. Information will be shared with specific dates and times from each school.

Building ReconfigurationGrade-level shifts for K-8 students include:

- Kindergarten through 4th grade at elementary
- 5th and 6th graders will go to Middle School North
- 7th and 8th graders will go to Middle School South

This shift brings several advantages, ensuring a more unified and equitable experience for students. Key benefits include:

- Expanded Opportunities All students will have access to swimming, Career and Technical Education (CTE) classes, and the reintroduction of 5th grade band.
- Stronger Community Connections Students will grow up together from an earlier age, fostering stronger bonds and a more cohesive experience across academic and extracurricular programs, including athletics.
- Eliminating the Split Between Schools This configuration removes the current division between middle school buildings, providing a seamless transition for students as they advance through their education.

SC4 Enhanced Dual Enrollment

ABHS is partnering with St. Clair County Community College (SC4) to offer students Enhanced Dual Enrollment opportunities. SC4 has designed three specialized pathways that align with our Career & Technical Education programs:

- Nursing Complete SC4's Associate Degree Nursing program prerequisite courses by the end of 12th grade.
- Business Earn college credits toward a Business
- Michigan Transfer Agreement (MTA) Complete up to 25 transferable college credits.


Inspiring Future Tech Leaders

The bond program is laying the foundation for a stronger, more innovative learning environment for all students - one that will benefit our community for years to come!





Annual Required Notifications

The following notices are required by law for Anchor Bay School District to publish annually to its community. The notices make community members aware of their rights in regard to directory information, education records, pupil rights, etc. More annual notifications are available online at www.anchorbay.misd.net under the "Parent" tab.

Directory Information

The federal law known as the Family Educational Rights and Privacy Act (FERPA) affords parents and students who are 18 years of age or older ("eligible students") certain rights with respect to the student's education records. These rights are:

- 1) The right to inspect and review the student's education records within 30 days after the day the School District receives a request for access. Parents or eligible students who wish to inspect their education records should submit to the school principal a written request that identifies the records they wish to inspect. The principal or designee will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected.
- 2) The right to request the amendment of education records that the parent or eligible student believes are inaccurate, misleading, or otherwise in violation of the student's privacy rights under FERPA. Parents or eligible students who wish to ask the School District to amend their child's or their education record should submit a written request to the school principal, clearly identifying the part of the record they want changed and specifying why they believe it should be changed. If the School District decides not to amend the record as requested, the school will notify the parent or eligible student of the decision and of their right to a hearing regarding the request for amendment. Additional information regarding hearing procedures will be provided to the parent or eligible student at the time they are notified of the right to a hearing.
- 3) The right to provide written consent before the School District discloses personally identifiable information (PII) from the student's education records, except to the extent that FERPA authorizes disclosure without consent. One exception, which permits disclosure without consent, is disclosure to school officials with legitimate educational interests. A designated school official with a legitimate educational interest includes a person employed by the School District as an administrator, teacher, or other person designated by the Board of Education. A school official also includes a liaison officer who, while not employed by the School District, may be granted access to student educational records (including video footage) at the direction and supervision of a school administrator. A school official also may include a contractor or consultant who, while not employed by the School District, performs an institutional service or function (such as design and maintenance of the School District's security camera system) for which the school would otherwise use its own employees and who is under the direct control of the School District with respect to the use and maintenance of personally identifiable information from student education records.
- 4) The right to refuse to allow the disclosure of "directory information". The word "parents," when used in these Annual Notifications includes legal guardians and, where required by law, those acting in the place of parents. "Directory information" regarding a student may be released to any requesting person or party, in addition to the eligible student or his/her parent, without written consent. The Board of Education has defined "directory information" to include a student's: Name; Address and telephone number; Photograph; Birth date and place of birth; Participation in School District related programs and extracurricular activities; Academic awards and honors; Height and weight, if a member of an athletic team; Honors and awards; and Dates of attendance and date of graduation. In the event inconsistency exists between the Board of Education policy defining "directory information" and this annual notification, the policy prevails.

Each year, the Superintendent, or his/her designee, will provide public notice to students and parents of the School District's intent to make directory information available to students and parents. Common uses for students' directory information, which include, but are not limited to: a student's name, address and telephone number; a student's photograph; a student's birth date and place of birth; a student's participation in School District related programs and extracurricular activities; a student's academic awards and honors;

a student's height and weight, if a member of an athletic team; a student's honors and awards; and a student's dates of attendance and date of graduation. If you do not want the School District to release your or your student's directory information, you may. Eligible students and parents may refuse to allow the School District to disclose any or all of such directory information upon written notification to the School District within thirty (30) days after receipt of the School District's public notice. Parents may submit written notification to the building principal of their child's school and/or fill out the attached FERPA Opt-Out Form.

5) The right to file a complaint with the United States Department of Education concerning alleged failures by the School District to comply with the requirements of FERPA. Nondiscrimination

No person may be denied admission to any school in the School District, be denied the benefits of or be discriminated against in any curricular, extracurricular, or other School District program or activity based on the person's gender, religion, race, color, national origin or ancestry, age, disability, marital status, or any other legally protected characteristic. The Board of Education has adopted a Discrimination and Harassment Policy which prohibits all forms of illegal harassment and discrimination within the School District. Any person who believes that he/she has been the victim of discrimination may seek resolution of his/her complaint through the procedures that have been established by the School District. A person wishing to pursue a complaint may also contact the School District's Civil Rights Compliance Officer, (the Special Education Supervisor at 586-725-2861, or visit the Special Education offices at 5201 County Line Road, Casco 48064, during regular business hours (8a.m. – 4:30 p.m.).

Protection of Pupil Rights Amendment (PPRA)

Under the federal Protection of Pupil Rights Amendment (PPRA) and School District policy, no student will be required as a part of the school program or the School District's curriculum, without prior parental consent, to submit to or participate in any survey, analysis or evaluation that reveals information concerning:

- Political affiliations or beliefs of the student or his/her parents;
- Mental or psychological problems of the student or his/her family;
- Sexual behavior or attitudes;
- Illegal, anti-social, self-incriminating, or demeaning behavior;
- Critical appraisals of other individuals with whom students have close family relationships;
- Legally-recognized privileged and analogous relationships, such as those of lawyers, physicians, and ministers;
- Religious practices, affiliations, or beliefs of the student or his/her parents; or
- Income (other than that required by law to determine eligibility for participation in a program or for receiving financial assistance under such a program).

This requirement also applies to the collection, disclosure, or use of student information for marketing purposes ("marketing surveys"), and certain physical examinations and screenings. Parents have the right to inspect, upon request, a survey or evaluation created by a third party before the survey/evaluation is administered or distributed by the school to the student. The parent will be given access to the survey/evaluation within a reasonable period of time after the request is received by the building principal. Parents who believe their rights have been violated may file a complaint with: Student Privacy Policy Office U.S. Department of Education 400 Maryland Avenue SW Washington, DC 20202.

Public Pesticide Application Notice

The Board of Education has adopted a policy to provide students and staff with an environment that is free of pests, pesticides, and harmful chemicals to the extent required by law. The Integrated Pest Management Program (IPM) includes routine inspections or surveys of all school facilities and various strategies to prevent pests from becoming a problem. Pesticides are used only as a last resort and parents will be notified prior to a pesticide application in a school building or on school grounds.
